

ATCO 'Movies at the Meadows' Contest Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** This Contest is open only to those who sign up at www.ATCO.com/spruce-meadows and who 18 years of age or older as of the date of entry. The Contest is only open to legal residents of Alberta, Canada and is void where prohibited by law. Employees of ATCO, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Contest.
