- Comment: Should people contact NextEra or Suncor if concerns arise when installing the shared facilities?
 - o Response: NextEra is responsible for installing shared facilities.
- Comment: Will Suncor contact adjacent landowners when installing collector lines in front of properties?
 - o Response: Yes, Suncor will be notifying landowners to ensure safety concerns are identified.
- Comment: When will the turbines be lit with navigation lighting as this was delayed at Bornish?
 - Response: Turbines that require navigation lighting will have lights installed prior to turbine
 erection. Temporary generators will then provide power to the lights until the Project is
 operational. 14 of the 18 turbines will have navigation lighting.
- Comment: Is the RUA close to being signed with the Township?
 - o Response: Yes. The goal is for it to be in front of Council on May 21st. Suncor has an executed RUA with the County of Middlesex.

What's happening in the community - information sharing:

• Comment: There have been several encounters with upset landowners during NextEra construction, including vandalism to contractor equipment, thefts, personal threats, etc.

Future items/topics discussed:

- Comment: Lake Huron Primary Water Supply System impacts to the facility, access to the facility, etc. Request to show the system within project mapping to ensure contractors are aware before works take place.
 - Response: Suncor will work to address the concerns prior to works within the road right-of-way are initiated. To be discussed directly with LHPWSS.
- Comment: What were the notifications given to the public regarding CLC Meetings?
 - Response: There was a public notice put in local papers requesting membership. There was no notification to the general public regarding this meeting; however Suncor is open to advertising the next meeting regarding project construction.
- Comment: Does Suncor enter into Community Vibrancy Funds or similar?

- Response: Supporting local communities is important to us and Suncor is committed to do so in a number of ways local jobs, supply/service contracts, tax revenue, etc. We also support local community organizations and initiatives through our community investment programs.
- Comment: What guarantee/insurance can Suncor provide that the turbines will be removed once operation is complete?
 - Response: Suncor has optioned lease agreements with landowners which includes the requirement to remove the infrastructure. If the project is sold, this requirement is transferred to the new project owner. In addition, material value is considerable at the time of removal.
- Comment: How much material as part of the foundations will be removed?
 - o Response: To a depth of 1m below grade.
- Comment: Is there an opportunity for a tour of the construction site?
 - Response: Suncor will look into the options that are available considering health and safety implications. Suncor will also look into options for a tour during facility operation.
